LIABILITY CHECK LIST

1. Inspect the field, backstop, all the lines, the bases, pitching
2. Inspect ALL bats of BOTH teams.
2. Remind both teams of jewelry removal.
4. Catchers: helmets, chest protectors, masks, cup, shin guards.
- e. Be alert regarding encroachment of spectators onto playing field
6. Be alert for playing equipment (gloves, bats, masks, etc.) on playing field.
2. Regarding INJURED PLAYERS:
 - a. DO NOT assist, help or move any in player.
 - b. DO NOT force the remove of an injured player from the playing area. Allow coach/trainer to give necessary treatment prior to resuming play.
8. Regarding HAZZARDS on the FIELD :
 - a. DO NOT remove, or help in removing any hazardous material from the playing area.
 - b. DO NOT help in making a field playable after a rain or similar problem.
5. DO NOT play under hazardous conditions!
DO NOT play with hazardous equipment
c. /a. = play with encroaching spectators!
